It is **ORDERED** and **DIRECTED** that said Stipulation of Settlement is hereby accepted and judgment is awarded in favor of Plaintiff, Masco/Adcom, Inc. and against the Defendant, Department of Commerce in the sum of \$687.75, together with interest at the legal rate of six percent (6%) per annum from January 30, 1986.
