January 12, 1988

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 12th day of January 1988, in reviewing the record, correspondence of the parties and the recent joint request of counsel, and it appearing it would be in the best interest of justice that the parties be given additional time for negotiations for settlement purposes, this matter shall be **STAYED** for a period of sixty (60) days from the date of this Order. On said date or prior thereto, counsel for the parties should advise the Board of settlement, the same being accomplished or to lift the Stay and order the matter to a hearing." January 15, 1988

Accordingly, this case will be closed in accordance with Board's Order signed simultaneously with the signing of this Order."

November 4, 1988

The Board made the following Order: "**AND NOW**, this 4th day of November, 1988, in accordance with an Opinion of the Board dated November 4, 1988 containing a chronological history of the entire case evidencing a settlement between the parties, the conditions of the settlement, the execution of the settlement and the acceptance of the settlement on behalf of both the Plaintiff and the Defendant, the Board hereby **DIRECTS** that this case be marked settled and closed with prejudice. Each party to bear its own costs."
