The Board rendered an Opinion and made the following Order: "AND NOW, this 15th day of September, 1987, we find in favor of the Plaintiff, Dick Enterprises, Inc. for the Use and Benefit of AKM Associates, Inc. and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Eighty-Three Thousand Three Hundred Eleven Dollars and Seventy-five Cents (\$83,311.75) established in the following manner: Materials cost - \$1,696.00, Labor Cost - \$60,795.15, Equipment cost - \$2,851.40 = Subtotal - \$66,359.39, 25% Overhead - \$16,589.85 = Total Cost -\$82,949.24, 2% Sub-contractor - \$1,658.98 = GRAND TOTAL - \$83,311.75. Interest at the legal rate of six (6%) percent per annum beginning thereon from September 30, 1985 shall be granted. Each party to bear its own costs."
