That the Commonwealth of Pennsylvania, Department of Transportation, Defendant, shall pay to the Plaintiff, Dick Enterprises, Inc. the sum of Six Thousand One Hundred and no/100 (\$6,100.00) Dollars in full settlement of all claim arising out of said Contract No. 30124. 2. That in consideration of said payment, Dick Enterprises, Inc. shall release and forever discharge the Commonwealth of Pennsylvania, Department of Transportation from all claims, action, suits, causes of action and demands for damages of whatever nature concerning, rising out of or relating to said Contract No. 30124, including, but not limited to, the action heretofore docketed with Board of Claims. Specially excluded, however, disposition of the Claims as it might relate to any of the parties

in the Claim of Columbia Gas of Pennsylvania, Inc. vs. Department of Transportation, Board's Docket No. FC-422-85."
