The Board rendered an Opinion and made the following Order: "AND NOW, this 26th day of March 1987, upon consideration of the pleadings and admissions contained therein, it is hereby ORDERED and DECREED that an award be and hereby is made in favor of the Plaintiff, Waste Automation Corporation, and against the Commonwealth of Pennsylvania, Department of Military Affairs, in the amount of Ten Thousand Seven Hundred Ninety-Nine Dollars and Ninety-Eight Cents (\$10,799.98) for the billings through August 1986. It is further ordered that for all services satisfactorily performed after that date at the following locations, payment shall be made to the Plaintiff, Waste Automation Corporation, by the Defendant, Commonwealth of Pennsylvania, Department of Military Affairs, at the following rates per month: Lancaster Ave. - \$370 per month, Ogontz Ave. - \$228 per month, S. 23rd St. - \$200 per month, until the termination date of the pertinent Contract or prior praecepe of a party hereto requesting the reopening of the matter.
