May 1987 - \$5,737.50, 4. June 1987 - \$3,950.00, 5. July 1987 - \$150.00. We further find, in favor of Plaintiff, interest at the rate of six percent (6%) per annum to begin in the following manner: 1. Six percent (6%) will begin on the February bill in June, 1987. 2. Six percent (6%) will begin on the April bill in August, 1987. 3. Six percent (6%) will begin on the May bill in September, 1987. 4. Six percent (6%) will begin on the June bill in October, 1987. 5.
