The Board rendered an Opinion and made the following Order: "**AND NOW**, this 7th day of April, 1989, upon approval of the Stipulation and Settlement Agreement, it is hereby **ORDERED** and **DECREED** as follows:

1. That the Respondent, Commonwealth of Pennsylvania, Department of Corrections shall pay to Claimant, Gundrum, Ltd., t/a Walker Company the sum of \$10,050.00 in total settlement, including costs, of the claim in this matter. 2. Claimant agrees to withdraw its Complaint at this docket number and agrees to release the Respondent, its agencies and agents from any and all proceedings. 3. The Claimant upon receipt of said award is directed to file Praeipie notifying the Board of receipt of said monies and authorizing withdrawal of the Complaint with prejudice. Each party to bear its own costs, other than the filing fee included in the settlement amount." Copy forwarded to attorney for Plaintiff and attorney for Defendant.
