The Board rendered an Opinion and made the following Order: **AND** Now, this 25th day of May, 1989, premised on the record, the pleadings herein and the testimony presented, it is hereby **ORDERED** and **DIRECTED** that the settlement between the parties is hereby accepted, and that the defendant, Commonwealth of Pennsylvania, Department of Public Welfare, is obligated and **DIRECTED** to pay the Plaintiff, Pennsylvania State University, the sum of Seventy-Eight Thousand Six Hundred Forty-Two Dollars and Thirteen Cents (\$78,642.13) in full satisfaction of the Claim. It is further **ORDERED** that upon receipt of payment of said Award, Plaintiff shall forthwith file with the Board a Praeipie that the case be marked settled, discontinued and ended with prejudice.
