The Board rendered an Opinion and made the following Order: "**AND NOW**, this 17th day of July, 1989, upon due consideration of the pleadings and other submissions filed in this matter, it is hereby

**ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Nittany Building Specialties, Inc., and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Fifteen Thousand Two Hundred Sixty-Three Dollars (\$15,263.00). Demand for the filing and such other relief are merged in this award. It is further **ORDERED** that upon receipt of payment of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked settled, discontinued and ended with prejudice. Each party to pay its own costs except as otherwise indicated." Copies forwarded to attorney for Plaintiff, attorney for Defendant and Chief Deputy Attorney General.
