July 28, 1989

The Board rendered an Opinion and made the following Order: **"AND NOW,** this 28th day of July, 1989, upon consideration of the Claim filed on behalf of the Plaintiff in this matter, Pavex, Incorporated, and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, it is hereby **ORDERED** that judgment is entered in favor of Plaintiff, Pavex, Incorporated, and against the Defendant in the amount of Five Thousand Five Hundred Dollars (\$5,500.00).

July 28, 1989 (cont'd)

Upon receipt of payment of said award, Plaintiff shall forthwith file with the Board a Praecipe that the case be marked settled and ended with prejudice. Each party to bear its own costs." Copies forwarded to attorney for Plaintiff and attorney for Defendant.

August 1, 1989

This Rule shall become absolute and the case shall be marked closed and settled with prejudice in the event the Board does not receive a response to said Rule." Copies forwarded to attorney for Plaintiff and attorney for Defendant.**
