The Board rendered an Opinion and made the following Order: "**AND NOW**, this 22nd day of September, 1989, upon due consideration of the Pleadings and other submissions filed in this matter it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Wilbur Smith Associates, and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Seventeen Thousand One Hundred Forty-Five Dollars and Forty-Seven Cents (\$17,145.47). Demand for the filing fee and such other relief are merged in this award. It is further **ORDERED** that upon receipt of payment of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked settled, discontinued and ended with prejudice. Each party to pay its own costs except as otherwise indicated." Copy forwarded to attorney for Plaintiff and attorney for Defendant.
