January 24, 1990

The Board rendered an Opinion and made the following Order: **"AND NOW**, this 24th day of January 24, 1990, upon due consideration of the Statement of Claim, the Petition to Approve Settlement and the Agreement, it is hereby **ORDERED** and **DECREED** that the Petition to Approve Settlement and the Settlement Agreement be and hereby are **APPROVED**, and that the Defendant, Commonwealth of Pennsylvania, Department of the Auditor General is obligated to pay the sum of Fifty-Nine Thousand Nine Hundred Fifteen Dollars and Twenty-Five Cents (\$59,915.25) in full satisfaction and settlement of this matter. Upon receipt of payment of said award, Plaintiff shall file a Praecipe with the Board of Claims requesting that the matter be marked settled and discontinued with prejudice. Each party to bear its own costs." Copies forwarded to attorney for Plaintiff, attorney for Defendant and Chief Deputy Attorney General.

January 25, 1990

This Rule shall become absolute and the case shall be marked closed and sealed with prejudice in the event the Board does not receive a response to said Rule." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

January 4, 1991

The Board and made the following Order: **"AND NOW**, this 4th day of January, 1991, pursuant to Letter Praecipe acknowledging receipt of payment of money filed by David F. Girard-DiCarlo, Esquire on behalf of Plaintiff, Blank, Rome, Comisky & McCauley received by this Board under date of December 28, 1990, it is hereby **ORDERED** and **DIRECTED** that the case be marked 'settled, discontinued and ended with prejudice.'"
