The Board rendered an Opinion and made the following Order: "**AND NOW**, this 1st day of February, 1990, premised on the record, the pleadings filed, and the testimony presented, it is hereby **ORDERED** and **DECREED** that the negotiated settlement be and hereby is approved, and that the Defendant, Commonwealth of Pennsylvania, Department of Transportation, is obligated to pay the full and true sum of One Hundred Forty-Three Thousand Two Hundred Three Dollars and Forty-Eight Cents (\$147,203.48) to the Plaintiff, Rummel, Klepper & Kahl. The interest and costs, if any, are merged into the settlement figure of One Hundred Forty-Three thousand Two Hundred Three Dollars and Forty Eight Cents (\$147,203.48). Upon receipt of the award by Plaintiff, Plaintiff shall forthwith file with the Board of Claims, a Praecipe to mark the case settled, discontinued and ended with prejudice." Copy forwarded to attorney for Plaintiff and attorney for Defendant.
