The Board rendered an Opinion and made the following Order: "**AND NOW**, this 16th day of March, 1990, upon due consideration of pleadings filed in this matter, it is hereby **ORDERED** and **DECREED** that an award be made in favor of Plaintiff, Fineman & Bach, P.C. and against the Defendant, Commonwealth of Pennsylvania, Independent Regulatory Review Commission, in the amount of Forty-four thousand Four Hundred Five Dollars and Eleven cents (\$44,405.11) plus interest at the legal rate of six percent (6% per annum) beginning from December 20, 1988, the date of the filing of the Complaint. It is further **ORDERED** that upon receipt of payment of said award, Plaintiff shall forthwith file with the Board of Claims a Petition requesting that the case be marked settled, discontinued and ended with prejudice. Each party to bear its own costs." Copies forwarded to attorney for Plaintiff, attorney for Defendant, and Chief Deputy Attorney General.
