The Board rendered a final Opinion and made the following Final Order:  
"AND NOW, this 19th day of March 1991, it is hereby **ORDERED** and **DECREED** that an award is made in favor of the Plaintiff, Gerald E. Karl, and against the Defendants, Commonwealth of Pennsylvania, Department of General Services and the Pennsylvania State Police, in the amount of Fifteen Thousand Hundred Fifty Dollars (\$15,750.00) with interest at the legal rate per annum of six percent (6%) from January 1, 1990. Upon receipt of same award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked settled, discontinued and ended with prejudice.
