The Board rendered an Opinion and made the following Order: **"AND NOW,** this 16th day of July, 1993, upon due consideration of the Agreement and Release of the parties and other submissions, it is hereby **ORDERED** that Defendant, Commonwealth of Pennsylvania, Department of Transportation, shall pay to Plaintiff, Carmen Paliotta, an individual t/d/b/a Carmen Paliotta Contracting Company, the sum of Seven Thousand Two Hundred Fifty Dollars (\$7,250.00), in full satisfaction and settlement of the matter. Plaintiff shall withdraw its Complaint and upon payment of the within award, file a Praecipe with the Board of Claims requesting that the matter be marked 'settled and discontinued with prejudice'. Each party to bear its own costs and attorneys' fees other than the filing fee which is included in the award. Copy forwarded to attorney for Plaintiff and attorney for Defendant.
