The Board rendered an Opinion and made the following Order: **"AND NOW,** this 13th day of August, 1990, upon consideration of the pleadings in this matter, it hereby **ORDERED** and **DECREED** that an award be made in favor of Plaintiff, The Institute for Safety Analysis, Inc., and against the Defendant, Commonwealth of Pennsylvania, Office of attorney General, in the amount of Thirteen Thousand Seven Hundred Sixteen Dollars and Twenty-Five Cents (\$13,716.25). Further, in consideration of Defendant's Answer, it is **ORDERED** and **DECREED** that the Plaintiff shall be reimbursed the statutory filing fee of Fifty Dollars (\$50.00). Upon receipt of said award, Plaintiff shall forthwith file with the Board a Praecipe that the case be marked settled, discontinued and ended with prejudice. Each party to bear its own costs."
