June 28, 1990

Copies of Complaint forwarded to attorney for Defendant and Chief Deputy Attorney General.

July 2, 1990

Acceptance of Service of Complaint received from attorney for Defendant. Receipt of same acknowledged by attorney for Defendant June 29, 1990.

July 9, 1990

Acceptance of Service of Complaint received from Chief Deputy Attorney General. Receipt of same acknowledged by Chief Deputy Attorney General June 29, 1990.

July 26, 1990

Letter/Answer recommending payment in the amount of \$491.60 filed by attorney for Defendant. Copy forwarded to attorney for Plaintiff by attorney for Defendant.

October 15, 1990

The Board rendered an Opinion and made the following Order: **"AND NOW,** this 15th day of October, 1990, after due consideration of the Claim and demand of Dome Corporation of America, and the Answer of the Commonwealth of Pennsylvania, Department of Transportation, it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Dome Corporation of America, and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Four Hundred Forty-One Dollars and Sixty Cents (\$441.60), and the cost of the filing fee in the sum of Fifty Dollars (\$50.00), for a total sum of Four Hundred Ninety-One Dollars and Sixty Cents (\$491.60). Upon receipt of said award, Plaintiff shall forthwith file with the Board a Praecipe that the case be marked closed and ended with prejudice. Each party to pay its own costs other than the filing fee included in the award. Copies forwarded to Plaintiff, attorney for Defendant and Chief Deputy Attorney General.

This rule shall become absolute and the case shall be marked closed and settled with prejudice in the event the Board does not receive a response to said Rule." Copies forwarded to attorney for Plaintiff and attorney for Defendant.

May 14, 1991

It is, therefore, **DIRECTED** that the Rule of May 10, 1991 be made **ABSOLUTE** and the record be marked closed and settled with prejudice."
