**August 8, 1990**

Acceptance of Service of Complaint received from attorney for Defendant. Receipt of same acknowledged by attorney for Defendant August 6, 1990.

**August 10, 1990**

Acceptance of Service of Complaint received from Chief Deputy Attorney General. Receipt of same acknowledged by Chief Deputy Attorney General August 6, 1990.

**September 1, 1990**

Answer of the Department of Public Welfare and New Matter filed by attorney for Defendant. Copy forwarded to Plaintiff by attorney for Defendant.

**September 19, 1990**

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 19th day of September, 1990, upon due consideration of the pleadings and submissions in this case, it is **ORDERED** and **DECREED** that an award be entered in favor of the Plaintiff, Freeman Consulting Corporation, and against the Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, Office of Fraud and Abuse Investigation and Recovery, in the amount of Eight Thousand Seven Hundred Five Dollars and Four Cents (\$8,705.04). It is further **ORDERED** and **DECREED** that the above award shall bear interest at the legal rate of six (%6) percent per annum from July 30, 1990 until paid. It is further **ORDERED** and **DECREED** that, in accordance with the response of the Defendant, the Plaintiff be reimbursed the Fifty-Dollar (\$50) statutory filing fee. upon receipt of said award, Plaintiff shall forthwith file with the Board a Praecipe to mark the case closed and ended with prejudice. Each party to bear its own costs." Copies forwarded to Plaintiff, attorney for Defendant and Chief Deputy Attorney General.
