The Board will assign Docket number 1462 A to Dr. Melvin Oram Amended Complaint and Docket number 1462 B to Dr. John Cacciamani Amended Complaint. The Board further orders that the cases will be consolidated as of the filing of the two Amended Complaints and will be tried as consolidated cases.
