The Board rendered an Opinion and made the following Order: "**AND NOW**, this 11th day of February, 1993, a Rule to Show Cause is issued upon Plaintiff, NovaCare, wherein it is directed that Plaintiff file its responsive pleading to the affirmative allegations set forth by the Defendant within thirty (30) days of this Order. This Rule shall become absolute and the case shall be marked closed and settled with prejudice in the event the Board does not receive a response to said Rule." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 17th day of June, 1993, this Order is issued as a result of the failure of Plaintiff, NovaCare, to respond to the affirmative allegations set forth by the Defendant within thirty (30) days of February 11, 1993. It is, therefore, **DIRECTED** that the Rule is made **ABSOLUTE** and that the record shall be marked 'closed and settled with prejudice'."
