The Board rendered an Opinion and made the following Order: "**AND NOW**, this 12th day of July, 1991, upon due consideration of the Stipulation and Settlement Agreement of the parties and other submissions, it is hereby **ORDERED** and **DECREED** that Defendant, Commonwealth of Pennsylvania, Department of Corrections, shall pay to Plaintiff, Pennsylvania Power & Light Company, Inc., the sum of Five Thousand Four Hundred Fifty-Seven Dollars and Fifty Cents (\$5,457.50), which amount shall include the Fifty-Dollar (\$50.00) filing fee paid by the Plaintiff to commence this action, in full satisfaction and settlement of the matter. Plaintiff shall withdraw its Statement of Claim and upon payment of the within award, file a Praecipe with the Board of Claims requesting that the matter be marked 'settled and discontinued with prejudice'. Each party to bear its own costs other than the filing fee included in the award."
