The Board rendered an Opinion and made the following Order: "**AND NOW**, this 26th day of September, 1991, upon due consideration of the proposed Settlement Agreement and Release of the parties and other submissions, it is hereby **ORDERED** that Defendant, Commonwealth of Pennsylvania, State Treasury Department shall pay to Plaintiff, Moorland Studios, Inc., the sum of Fifteen Thousand Dollars (\$15,000.00), which amount shall include the fifty Dollars (\$50.00) filing fee paid by the Plaintiff to commence this action, in full satisfaction and settlement of the matter. All other party Defendants are **STRICKED** from the record. Plaintiff has withdrawn its Complaint and filed a Praecipe with the Board requesting that the matter be held discontinued and satisfied. **IT IS SO ORDERED.**
