The Board rendered an Opinion and made the following Order: NOW, this 28th day of February, 1994, upon due consideration of the Settlement and Release Agreement of the parties and other submissions, it is hereby ORDERED that the Defendant, Commonwealth of Pennsylvania, Department of General Services, shall pay to Plaintiff, Riblet Tramway Company, Inc. a Washington Corporation, the sum of Twenty-Five Thousand Dollars (\$25,000.00), which amount shall include the Fifty-Dollar (\$50.00) filing fee paid by the Plaintiff to commence this action, in full satisfaction and settlement of the matter. Plaintiff, upon payment of the above amount, shall file a Praecipe with the Board of Claims requesting that the matter be marked 'withdrawn and discontinued with prejudice', and it is so ORDERED. Each party to bear its own costs and attorney fees other than the filing fee which is included in the award. Copy forwarded to attorney for Plaintiff and attorney for Defendant.
