Claim and filing fee filed by Plaintiff. Amount of Claim: \$2,100.00.

April 4, 1991

Copy of Claim forwarded to attorney for Defendant and Chief Deputy Attorney General.

April 10, 1991

Acceptance of Service of Claim received from Chief Deputy Attorney General. Receipt of same acknowledged by Chief Deputy Attorney General April 5, 1991.

August 19, 1991

Proposed Stipulation of Settlement filed by attorney for Defendant (Danna N. Reynolds, Assistant Counsel). Copy forwarded to Plaintiff by attorney for Defendant.

September 10, 1991

Answer to Claim admitting all allegations and New Matter filed by attorney for Defendant. Copy forwarded to Plaintiff by attorney for Defendant.

October 28, 1991

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 28th day of October, 1991, upon due consideration of the Pleadings and other submissions filed in this matter it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Don Dubbs Painting Contractor, and against the Defendant, Commonwealth of Pennsylvania, Pennsylvania State Police, in the amount of Two Thousand One Hundred Dollars (\$2,100.00). It is further **ORDERED** that upon receipt of payment of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked 'settled, discontinued and ended with prejudice'. Each party to pay its own costs." Copy forwarded to Plaintiff, attorney for Defendant and Chief Deputy Attorney General.

November 5, 1991

November 6, 1991

April 30, 1992

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 30th day of April, 1992, Rule to Show Cause is issued upon Plaintiff wherein it is directed that Plaintiff advise the Board within thirty (30) days of this Order whether or not Plaintiff has received the sum of money awarded or other justifiable response. This Rule shall become absolute and the case shall be marked closed and settled with prejudice in the event the Defendant does not receive a response to said Rule." Copy forwarded to Plaintiff and attorney for Defendant.

May 6, 1992

Acceptance of Service of Opinion and Order dated April 30, 1992 received from attorney for Defendant. Receipt of same acknowledged by attorney for Defendant May 4, 1992.

February 11, 1993

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 11th day of February, 1993, this Order is issued as a result of the failure of Plaintiff, Don Dubbs Painting Contractor, to advise the Board of Claims within thirty (30) days of April 30, 1992, whether or not Plaintiff received the monies directed be paid to said Plaintiff. It is, therefore, **DIRECTED** that the Rule of April 30, 1992, be made **ABSOLUTE** and the record be marked closed and settled with prejudice." Copy forwarded to Plaintiff and attorney for Defendant.

February 19, 1993
