The Board rendered an Opinion and made the following Order: "**AND NOW**, this 13th day of January, 1992, after due consideration of the Claim and demand of Edwin L. Heim Company, and the Answer of the Commonwealth of Pennsylvania, Department of Transportation, Bureau of Aviation, it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Edwin L. Heim Company in the amount of Six Thousand Eleven Dollars and Seventy Cents (\$6,011.70), plus the cost of the filing fee in the sum of Fifty Dollars (\$50.00), for a total of Six Thousand Sixty-One Dollars and Seventy Cents (\$6,061.70). Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked 'settled, discontinued and ended with prejudice'. Each party to bear its own costs other than the filing fee included in the award."
