The Board rendered an Opinion and made the following Order: **"AND NOW,** this 20th day of February, 1992, it is **ORDERED** and **DECREED** that the Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, is indebted unto the Plaintiff, Seymore Rubin, individually and t/a Seymore Rubin Associates, in the full and true sum of One Thousand Nine Hundred Ten Dollars (\$1,910.00). Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe to mark the case 'settled and ended with prejudice'. Each party to bear its own costs." Copies forwarded to attorney for Plaintiff and attorney for Defendant.

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 29th day of July, 1992, Rule to Show Cause is issued upon Plaintiff, Seymore Rubin, individually and t/a Seymore Rubin Associates, wherein it is directed that Plaintiff advise the Board within thirty (30) days of this Order whether or not Plaintiff has received the sum of money directed by the Board of Claims. This Rule shall be made absolute and the case shall be marked 'closed and settled with prejudice in the event the Board does not receive a response to said Rule.'" Copies forwarded to attorney for Plaintiff and attorney for Defendant.

May 26, 1993

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 26th day of May, 1993, this Order is issued as a result of the failure of Plaintiff, Seymore Rubin, individually and t/a Seymore Rubin Associates, to advise the Board of Claims within thirty (30) days of January 14, 1993, whether or not Plaintiff received the monies directed to be paid to said Plaintiff. Therefore, it is **DIRECTED** that the Rule of July 29, 1992, be made **ABSOLUTE** and the record be marked 'closed and settled with prejudice'." Copies forwarded to attorney for Plaintiff and attorney for Defendant.
