

Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe to mark the case 'settled and ended with prejudice'. Each party to bear its own costs." Therefore, it is DIRECTED that the Rule of July 29, 1992, be made ABSOLUTE and the record be marked 'closed and settled with prejudice'."
