The Board rendered an Opinion and made the following Order: "**AND NOW**, this 2nd day of March, 1992, after due consideration of the Claim and demand of HRI, Inc., and the Answer of the Commonwealth of Pennsylvania, Department of Transportation, it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, HRI, Inc., and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Three Thousand Three Hundred Twenty-Seven and Fifty Cents (\$3,327.50). Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked 'settled, discontinued and ended with prejudice'. Each party to bear its own costs other than the filing fee included in the award." Copies forwarded to attorney for Plaintiff, attorney for Defendant, and Chief Deputy Attorney General.
