**January 9, 1992**

Acceptance of Service of Claim received from attorney for Defendant. Receipt of same acknowledged by attorney for Defendant January 7, 1992.

January 13, 1992

**April 14, 1992**

The Board rendered an Opinion and made the following Order: **"AND NOW**, this 14th day of April, 1992, after due consideration of the Claim and demand of Keystone Sanitary Landfill, Inc. and the Answer of the Commonwealth of Pennsylvania, Department of Transportation, it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Keystone Sanitary Landfill, inc. and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Seven Thousand Three Hundred Sixty-Seven Dollars and Seventy Cents (\$7,367.70), plus the cost of the filing fee in the sum of fifty Dollars (\$50.00) for a total sum of Seven Thousand Four Hundred Seventeen Dollars and Seventy Cents (\$7,417.70).

**April 14, 1992 (cont'd)**

Upon receipt of payment of said award, Plaintiff shall acknowledge same and forthwith file with the Board a Praecipe that the case be marked settled and ended with prejudice. Each party to bear its own costs other than the filing fee included in the award." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

It is therefore DIRECTED that the record shall be marked 'closed and settled with prejudice'." Copies forwarded to Plaintiff and attorney for Defendant.
