The Board rendered an Opinion and made the following Order: **"AND NOW**, this 27th day of March, 1992, after due consideration of the Claim and demand of Pennsylvania Industries for the Blind and Handicapped, Inc., and the Answer of the Commonwealth of Pennsylvania, Department of Public Welfare, it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Pennsylvania Industries for the Blind and Handicapped, Inc., and against the Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, in the amount of Eight Thousand Five Hundred Ninety-Seven Dollars and Sixty-Six Cents (\$8,597.66), which amount includes the return of the Fifty-Dollar (\$50.00) filing fee. Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked 'settled, discontinued and ended with prejudice'. Each party to bear its own costs other than the filing fee included in the award." Copies forwarded to Plaintiff, attorney for Defendant and Chief Deputy Attorney General.
