**July 29, 1992**

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 29th day of July, 1992, after due consideration of the Claim and demand of Robert W. Hunt Company, and the Answer of the Commonwealth of Pennsylvania, Department of Transportation, it is hereby **ORDERED** and **DECREED** that an award be made in favor of the Plaintiff, Robert W. Hunt Company, and against the Defendant, Commonwealth of Pennsylvania, Department of Transportation, in the amount of Ten Thousand Five Hundred Seventy-Six Dollars and Seventy-Four Cents (\$10,576.74), plus the cost of the filing fee in the sum of Fifty Dollars (\$50.00), for a total sum of Ten Thousand Five Hundred Seventy-Six Dollars and Seventy-Four Cents (\$10,626.74). Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked settled, discontinued and ended with prejudice. Each party to bear its own costs and attorney fees other than the filing fee included in the award." Copies forwarded to Plaintiff, attorney for Defendant, and Chief Deputy Attorney General.
