Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe requesting that the matter be marked settled, discontinued and ended with prejudice. This Rule shall become absolute and the case shall be marked 'closed and settled with prejudice' in the event the Board does not receive a response to said Rule." It is, therefor, **DIRECTED** that the Rule of December 7, 1995, be made **ABSOLUTE** and the record be marked 'closed and settled with prejudice.'"
