September 23, 1992

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 23rd day of September, 1992, upon due consideration of the Stipulation and Settlement Agreement of the parties and other submissions, it is hereby **ORDERED** that Defendant, Commonwealth of Pennsylvania, Pennsylvania Human Relations Commission, shall pay to Plaintiff, Nickel Reporting Service, the sum of Six Thousand Three Hundred Eighty-Eight Dollars and Seventy-Six Cents, (\$6,388.76), which amount shall include the Fifty Dollar (\$50.00) filing fee paid by the Plaintiff to commence this action, in full satisfaction and settlement of the matter. Plaintiff shall withdraw its Statement of Claim and upon payment of the within award, file a Praecipe with the Board of Claims requesting that the matter be marked settled and discontinued with prejudice." Each party to bear its own costs and attorneys' fees except as set forth above. Copy forwarded to Plaintiff and attorney for Defendant.

October 5, 1992

October 22, 1993

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 22nd day of October, 1993, a Rule to Show Cause is issued upon Plaintiff, Nickel Reporting Service, wherein it is **DIRECTED** that Plaintiff advise the Board within thirty (30) days of this Order whether or not Plaintiff has received the sum of money awarded or other justifiable response. This Rule shall become absolute and the case shall be marked 'closed and settled with prejudice' in the event the Board does not receive a response to said Rule." Copy forwarded to Plaintiff and attorney for Defendant.

It is, therefore, **DIRECTED** that the Rule is made **ABSOLUTE** and that the record shall be marked 'closed and settled with prejudice'." Copy forwarded to attorney for Plaintiff and attorney for Defendant.
