The Board rendered an Opinion and made the following Order: "**AND NOW**, this 7th day of April, 1993, it is **ORDERED** and **DECREED** that the Defendant, Commonwealth of Pennsylvania, Department of Transportation, is indebted unto the Plaintiff, Urban Engineers, Inc., in the full and true sum of Forty Thousand Four Hundred Sixty-Nine Dollars and Forty-Eight Cents (\$40,469.48). Said sum includes the return of the Fifty-Dollar (\$50.00) statutory filing fee. Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praeceptum that the case be marked settled, discontinued and ended with prejudice. Each party to bear its own costs and attorneys' fees other than above noted." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

NOW, this 15th day of September, 1993, a Rule to Show Cause is issued upon Plaintiff, Urban Engineers, Inc., wherein it is **DIRECTED** that Plaintiff advise the Board within thirty (30) days of this Order whether or not Plaintiff has received the sum of money awarded or other justifiable response. This Rule shall become absolute and the case shall be marked 'closed and settled with prejudice' in the event the Board does not receive a response to said Rule."
