The Board rendered an Opinion and made the following Order: "**AND NOW**, this 3rd day of August, 1994, it is **ORDERED** and **DECREED** that the Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, is indebted unto the Plaintiff, Pennsylvania Association of Resources for People with Mental Retardation, in the full and true sum of One Hundred Thirty-Four Thousand Dollars (\$134,000.00). Upon receipt of payment of said award, Plaintiff shall forthwith file with the Board a Praecipe that the case be marked settled and ended with prejudice. Each party to bear its own costs and attorneys' fees." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

August 11, 1994

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 11th day of August, 1994, upon receipt of a Praecipe to Discontinue, executed by Jack M. Mumford, Esquire, on behalf of Plaintiff, Pennsylvania Association of Resources for People with Mental Retardation, which states 'Please mark the above-referenced proceeding discontinued with prejudice' same of which is docketed with this Board under date of August 5, 1994, it is **ORDERED** and **DECREED** that said case be marked 'settled, discontinued and ended with
