The Board rendered an Opinion and made the following Order: "**AND NOW**, this 16th day of May, 1994, upon due consideration of the Joint Motion for Approval of Settlement Agreement of the parties and other submissions, it is hereby **ORDERED** that Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, shall pay to Plaintiff, Pennsylvania Community Providers Association, the sum of One Hundred Eleven Thousand One Hundred Eighty-Three Dollars and Forty-Seven Cents (\$111,183.47) which amount shall include the Fifty-Dollar (\$50.00) filing fee paid by the Plaintiff to commence this action, in full satisfaction and settlement of the matter. Plaintiff shall withdraw its Complain and, upon payment of the within award, file a Praecept with the Board of Claims requesting that the matter be marked 'settled and discontinued with prejudice'." This Rule shall become absolute and the case shall be marked 'closed and settled with prejudice' in the event the Board does not receive response to said Rule." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

June 2, 1995

It is, therefore, **DIRECTED**, that the Rule of January 27, 1995, be made **ABSOLUTE** and the record be marked 'closed and settled with prejudice'."
