The Board rendered an Opinion and made the following Order: "**AND NOW**, this 11th day of June, 1993, it is **ORDERED** and **DECREED** that the Defendant, Commonwealth of Pennsylvania, Department of Transportation, is indebted unto the Plaintiff, B & B Pole Building, in the full and true sum of One Thousand Two Hundred Ninety-Two Dollars and Seventy-Five Cents (\$1,292.75), said sum to include the return of the Fifty Dollar (\$50.00) statutory filing fee incurred by the Plaintiff in perfecting its Claim. Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims, a Praecipe stating that the case be marked 'closed, settled and ended with prejudice.' Each party to bear its own costs and attorney fees, other than the filing fee as above noted." Copy forwarded to Plaintiff and attorney for Defendant.

This Rule shall become absolute and the case shall be marked 'closed and settled with prejudice' in the event the Board does not receive a response to said Rule." Copy forwarded to Plaintiff and attorney for Defendant.
