The Board rendered an Opinion and made the following Order: "**AND NOW**, this 29th day of October, 1993, upon due consideration of the Stipulation of Settlement of the parties and other submissions, it is hereby **ORDERED** that the Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, shall adjust its accounts and pay to Plaintiff, Maplewood Manor Convalescent, Inc. the sum which may be due after amendments to certified costs, which amount shall include the Fifty Dollar (\$50.00) filing fee paid by the Plaintiff to commence this action, in full satisfaction and settlement of the matter. Plaintiff, having withdrawn its Claim pursuant to its agreement, has now filed a Stipulated Praecipe with the Board of Claims requesting that the matter be marked 'withdrawn and discontinued with prejudice' and it is so **ORDERED**. Each party to bear its own costs and attorneys' fees other than the filing fee which is included in the award." Copy forwarded to attorney for Plaintiff and attorney for Defendant.
