The Board rendered an Opinion and made the following Order: "**AND NOW**, this 15th day of April, 1994, it is **ORDERED** and **DECREED** that the Defendant, Commonwealth of Pennsylvania, Department of Transportation, is indebted unto the Plaintiff, Urban Engineers, Inc., in the full and true sum of Thirty-Two Thousand Nine Hundred Sixty-Seven Dollars and Forty-Two Cents (\$32,967.42). Upon receipt of said award Plaintiff shall forthwith file with the Board of Claims a Praecipe to mark the case 'settled, discontinued and ended with prejudice'. Each party to bear its own costs and attorney fees." Copy forwarded to attorney for Plaintiff and attorney for Defendant.
