August 16, 1994

The Board rendered an Opinion and made the following Order: "**AND NOW**, this 7th day of July, 1995, it is **ORDERED** and **DECREED** that the Defendant, Commonwealth of Pennsylvania, Department of Corrections, is indebted unto the Plaintiff, Joerg's American Karate Studio, in the full and true sum of Nine Hundred Five Dollars and Sixty-One Cents (\$905.61). Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe that the case be marked settled, discontinued and ended with prejudice. Each party to bear its own costs and attorneys fees." Copy forwarded to Plaintiff and attorney for Defendant.
