Claim and filing fee filed by attorney for Plaintiff. Amount of Claim: \$159,988.50.

**November 30, 1994**

Copy of Claim forwarded to attorney for Defendant and Chief Deputy Attorney General.

---

**February 21, 1995**

Answer to Complaint filed by attorney for Defendant. Copy forwarded to attorney for Plaintiff by attorney for Defendant.

---

**May 20, 1996**

Entry of Appearance of Kenneth L. Gable, Esquire, on behalf of Plaintiff, filed by attorney for Plaintiff. Copy forwarded to attorney for Defendant by attorney for Plaintiff.

---

**April 13, 1997**

Letter forwarded to parties requesting status report. STATUS REPORT DUE MAY 5, 1997.

---

**April 11, 1997**

Status letter received from attorney for Defendant advising that the Department has not yet tendered payment but plans to in the near future. Anticipates that Plaintiff will then notify the Board of said payment.

---

**May 20, 1997**

Letter forwarded to parties requesting status report. Status Report due on or before June 19, 1997.

---

**May 29, 1997**

Letter/Status report received from Defendant advising that the Department has processed the supplemental agreement necessary to make payment to Plaintiff; the check should be cut in the next 2 weeks.

**July 14, 1997**

**July 22, 1997**

Letter received from attorney for Defendant advising that payment has been sent to Plaintiff.

**August 11, 1997**
