March 19, 1996

The Board rendered an Opinion and made the following Order: "AND NOW, this 19th day of March, 1996, it is ORDERED and DECREED that all proceedings herein be stayed pending settlement negotiations. Should said negotiations fail to result in a settlement, either counsel may request the Board to lift this stay of proceedings." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

The Board rendered the following Order: "AND NOW, this 8th day of August, 1996, it is ORDERED and DECREED that the Defendant, Commonwealth of Pennsylvania, Department of Transportation, is indebted unto the Plaintiff, Pennsylvania Industries for the Blind and Handicapped, in the full and true sum of Forty-Four Thousand Five Hundred Dollars (\$44,500.00). Upon receipt of said award, Plaintiff, shall forthwith file with the Board of Claims a Praecipe that the case be marked closed and settled with prejudice." Copy forwarded to attorney for Plaintiff and attorney for Defendant.

Cleckner, Esquire, on behalf of Plaintiff, Pennsylvania Industries for the Blind and Handicapped, which states: 'AND NOW this 14th day of August, 1996, please mark the above-captioned case settled and ended with prejudice.', same of which is docketed with this Board under date of August 15, 996, it is ORDERED and DIRECTED that said case be marked 'settled, discontinued and ended with prejudice.'"
