The Board rendered an Opinion and made the following Order: "AND NOW, this 22nd day of August, 1996, it is ORDERED and DECREED that Defendant, Commonwealth of Pennsylvania, Department of General Services, is indebted unto Plaintiff, The Milnes Co., Inc., in the amount of Forty-Four Thousand Two Hundred Seventy-Four Dollars (\$44,274.00). It is furthered ORDERED and DECREED that should Plaintiff fail to receive the \$44,274.00 within sixty (60) days of the exit date of this Order, the Plaintiff shall be entitled to receive interest at the legal rate of six percent (6%) per annum from that date until payment is actually received by the Plaintiff. Upon receipt of payment of said award, Plaintiff shall forthwith file with the Board a Praecipe that the case be marked settled and ended with prejudice. Each party to bear its own costs and attorneys' fees.
