The Board rendered an Opinion and made the following Order: **"AND NOW**, this 16th day of September, 1998, the Board finds in favor of the Plaintiff, Ernest Bock & Sons, Inc., and against the Defendant, Commonwealth of Pennsylvania, Department of General Services, in the amount of Fifty-Nine Thousand Nine Hundred Fifteen Dollars and Eighty-Seven Cents (\$59,915.87), with interest at the legal rate of six percent (6%) per annum from June 10, 1994 until date of payment on Thirteen Thousand Three Hundred Ten Dollars and Twenty-Six Cents (\$13,310.26), the door claim, and from January 18, 1995 until date of payment on Forty-Six Thousand Six Hundred Five Dollars and Sixty-Three Cents (\$46,605.63), the roof claim. Each party to bear its own costs and attorney fees. Upon receipt of said award, Plaintiff shall forthwith file with the Board of Claims a Praecipe requesting that the matter be marked "closed, discontinued and ended with prejudice."
