December 15, 1997

Acceptance of Service of Claim dated December 8, 1997 received from Chief Deputy Attorney General. Receipt of same accepted by Chief Attorney General December 10, 1997.

January 15, 1998

Answer and New Matter to Claim filed by Defendant. Copy forwarded to attorney for Plaintiff by attorney for Defendant.

January 23, 1998

Letter forwarded to Plaintiff directing them to file a response to the New Matter. Copy forwarded to attorney for Defendant.

February 26, 1998

Letter received from attorney for Defendant requesting a 30-day extension of time to file its responsive pleading to Plaintiff's Claim. Copy forwarded to attorney for Plaintiff by attorney for Defendant.

February 27, 1998
