August 13, 1998

Copy of Claim forwarded to attorney for Defendant and Chief Deputy Attorney General. ANSWER DUE FROM DEFENDANT September 14, 1998.

October 7, 1998

Answer and New Matter to Claim filed by attorney for Defendant.
Copy forwarded to attorney for Plaintiff by attorney for Defendant.

October 22, 1998

Letter forwarded to Plaintiff directing a response to New Matter. RESPONSE DUE 11/23/98.

November 20, 1998

Claimant's Reply to Respondent's New Matter filed by attorney for Plaintiff. Copy forwarded to attorney for Defendant by attorney for Plaintiff.

November 30, 1998

Letter forwarded to parties directing them to proceed with discovery.

September 1, 1999

Letter forwarded to parties requesting a status report. Now due 10/1/99.

September 17, 1999

Letter received from attorney for Plaintiff advising that the parties have been involved in extensive settlement negotiations regarding other Extendicare facilities for FYEs 6/30/92-6/30/94.
Once these claims are settled they will explore options to settle the above-captioned matter.

May 22, 2000

Status letter forwarded to parties. Due 6/22/00.

April 30, 2001

Letter forwarded to parties requesting a status. **Due 5/30/01.**

May 11, 2001

Letter received from attorney for Plaintiff advising that the parties are involved in extensive settlement negotiations regarding Extendicare's owned facilities FYEs 6/30/92 through 6/30/94. Once the parties resolve the claims being negotiated they will explore settlement options for the above matter.

January 3, 2002

Letter forwarded to parties requesting a status. **Response due 2/4/02.**

January 11, 2002

Letter received from attorney for Plaintiff advising that the parties recently resumed settlement negotiations regarding Extendicare's owned facilities FYEs 6/30/92 through 6/30/94. Once the parties resolve these claims being negotiated they will explore settlement options for the above claim.

July 16, 2002

Letter forwarded to parties requesting a Status Report. Status Report due on or before **August 15, 2002.**

July 25, 2002

Letter/status report filed by attorney for Plaintiff advising that the parties are not involved in settlement negotiations involving this matter, that once the parties resolve other claims they will then explore settlement options in this case.

October 12, 2005
