

August 20, 1998


Claim and filing fee filed by attorney for Plaintiff. Amount of Claim: in excess of \$300.00

June 30, 1999


Letter forwarded to parties requesting status report. Status Report due on or before **July 30, 1999**.

August 3, 1999

Letter/Status Report received from counsel for Plaintiff advising that they are currently in the process of transferring the handling of the matter to another attorney in the office and as soon as same is accomplished, the new counsel will be able to advise as to the status of the negotiations between the parties. They are hopeful of resolving this matter amicably.
