Copy of Claim forwarded to attorney for Defendant and Chief Deputy Attorney General. **ANSWER DUE FROM DEFENDANT SEPTEMBER 28, 1998.**

September 28, 1998

Answer and New Matter filed by attorney for Defendant. Copy forwarded to attorney for Plaintiff by attorney for Defendant.

September 29, 1998

Letter forwarded to Plaintiff requesting response to Defendant's New Matter. Response due October 29, 1998.

October 29, 1998

Plaintiff's Answer and New Matter filed. Copy forwarded to attorney for Defendant by attorney for Plaintiff.

October 30, 1998

Letter forwarded to parties directing the parties to commence with discovery.

November 23, 1999

Letter-type Stipulation of Withdrawal with Prejudice in Part of only that portion of pending disputes concerning 1993-1996 Home Office Costs filed by attorney for Plaintiff.
