January 29, 2002

The Board rendered an Opinion and made the following Order: **AND NOW**, this 29th day of January, 2002, the Board of Claims finding no issues of law or fact to be determined in the instant case, makes an award in favor of the Plaintiff, Lebanon Farms Disposal, Inc., and against the Defendant, Commonwealth of Pennsylvania, Department of Military and Veterans Affairs in the amount of Eight Thousand Three Hundred Seventy-Five Dollars and Fifty-Five Cents (\$8,375.55) plus interest at the legal rate of six percent (6%) per annum from the date the Claim was filed. Upon receipt of said award Plaintiff shall forthwith file a Praecipe with the Board of Claims, requesting that the matter be marked closed, discontinued and ended with prejudice.
